#### II. Animal Shelter update

- a. Artist: Dan Glanz
  - i. Sculptures, shared images
    - 1. Front entry piece "Leaps and Bounds"
    - 2. Piece for the Reflection Garden Needs a name; threw it out to the VAC for suggestions
- b. Artist: James Lynxwiler
  - Moving the budget from 50K to 45K, saving 5K to allow for art purchases once the building is complete – an opportunity to work with local, emerging artists
  - 2. Doing two main projects: Bike racks & Kiosks
    - a. Kiosks:
      - i. Decision is to go with the "scene" kiosks first shown to the VAC
      - ii. No words
      - iii. A variety of scenes depicting animals
      - iv. Want the finish to be whatever requires less maintenance
        - 1. Corten steel will rust (intentionally), but that may cause staining on the sidewalks
        - 2. Powdercoat is very durable but will this need much upkeep?
          - a. Colors suggested: blues/greens to fall in line with the park and river
          - b. Defer to artist

v. Qty: tbd

3. Bike rack – showed rendering

- a. VAC members still a little concerned that it may not be intuitively a bike rack and had a few suggestions:
  - i. Ensuring it "looks" like a bike rack (this could mean some kind of emblem/signage if need be)
  - ii. Fits the variety of bike locks out there
  - iii. Placed in such a way many bikes can fit at once -to ensure maximum use
  - iv. Add a caterpillar into the design
- ii. OAC / Artist meeting October 10 to determine final placement, materials, sizes, quantity, etc.
  - 1. Send invitation to the OAC meeting to VAC members present

- a. Name & Focus

  - ii. Suggested new name: Arts & Culture Commission
    - 1. Didn't vote on it, but all present agreed with the proposed change
- b. Process
  - i. Based upon an increase in projects planned moving forward, as well as the variety of projects we are looking at doing, we are altering the process for artist selection up, depending on the project
  - Example: For the upcoming Veteran's Memorial project, two members from the VAC will sit on the selection committee, in addition to the landscape architects, county project manager, veteran's affairs commission member(s), Parks, Open Space & Cultural Arts director
