WHEREAS, members appointed to the NCR Board are to be from one of the following disciplines: Law Enforcement, EMS-Fire Based, EMS-Non-Fire Based, Emergency Management, Fire, Public Health, Government Administration, Health Care, Hazardous Materials, Public Safety Communications, Public Works); and,

WHEREAS, appointed NCR Board members are to provide representation for all of the responder agencies and organizations within the County.

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners, County of Adams, State of Colorado, that NCR Board vacancies shall filled in accordance with the terms below:

- 1. When a vacancy exists, the Board shall seek nominations from each of the recognized NCR disciplines listed above by asking the Office of Emergency Management to solicit recommendations from representatives of each discipline within Adams County.
- 2. The term for NCR Board members appointed from Adams County shall be two years with one vacancy to be addressed on odd years and the other vacancy to be addressed on even years.
- 3. At no point in time shall appointed members be from the same discipline.
- 4. Adams County appointed NCR Board members are expected to provide representation for all of the responder agencies and organizations within the County by coordinating and communicating NCR Board information to the recognized NCR disciplines.

5. The Board reserves the right to remove members at any time if the Board determines they are not fulfilling member obligations.
