This is a three-step process to get a temporary permit, title the vehicle, and apply for registration:

- Email all the documents listed below to our secure email address.
 - a. Upon approval of the documents, we will contact you for payment of the \$7.08 permit fee and sales tax based on the purchase price. Find your tax rate here.
- 2. Mail the documents previously submitted by email and a check for \$7.20, made payable to Adams County Clerk, in the self-addressed, stamped envelope included in the permit packet mailed to you.
 - a. We will process the title and send you a title complete notice.
 - b. Credit cards cannot be accepted for this part of the process. A check or money order must be provided to process the title.
- 3. Upon receipt of the title complete card, apply for initial registration online or contact us by phone at 720-523-6310 to complete registration.
 - a. A passing emission test (if required) and proof of insurance are required.

The following documents are required to title and register the vehicle:

- Cover Sheet with contact information.
- Colorado Title. Before this is sent into us make sure the following are checked and completed:
 - All owners on the front of the title have printed (as shown on the face of the title) and signed their name as seller on the back of the title.
 - All new owners (buyers) have printed and signed (if multiple owners, only one signature is required) their name on the buyer section of the back of the title.
 - The odometer is filled in and the odometer indicator is checked. This only applies to vehicles 9 years old or **newer**. Transferring the odometer is not necessary for any vehicle that is 10 years old or older.
 - o The date of sale is listed on the back of the title.
 - o The agreed upon purchase price is listed on the back of the title.

- Current Proof of Insurance for this vehicle if requesting plates or temporary permit.
- Proof of a passing emission test if required

- If an emission test is not required, we can issue new plates or transfer license plates from another vehicle if there is at least one owner in common on both vehicles.

To create joint tenancy with rights of survivorship, there must be specific language declaring such intent, signed under penalty of perjury in the second degree by all owners. This form is only applicable to multiple owners.

Joint Tenancy with rights of Survivorship is defined as: A form of legal co-ownership of property (also known as survivorship). At the death of one co-owner, the surviving co-owner becomes sole owner of the property. Transfer of ownership requires copy of death certificate and signature of survivor.

Tenancy in Common is defined as: The equal or unequal holding of property by two or more persons. At the death of one co-owner, the deceased share of the property goes to his/her estate and is to be divided according to his/her will or the law in the absence of a will. Transfer of ownership requires documents appointing a personal representative for the decedent.
